## **Anlage 1: Bericht**

12. April 2018

### **Bericht über die Tagungsreise nach St Louis, Mo.**

Am **Donnerstag, den 9. März 2018**, bin ich nach der Ankunft am frühen Abend im Hotel angekommen.

Abends erfolgte ein Arbeitsessen mit den drei Kolleginnen (Molly Taylor-Poleskey, Susan Sutherland, Lucia Staiano-Daniels), mit denen ich am folgenden Tag das Panel bestritt.

**Working title:** Bottom-up Views on War & Peace in Early Modern German Europe

**Chair:** Molly Taylor-Poleski (Middle Tennessee State U)

**Session Abstract:** Both to contemporaries and later-born generations, the Thirty Years' War constituted a watershed in Central European history. Over the past two centuries, the war, its end, and its long-term consequences fascinated legions of scholars from disciplines as diverse as History, Sociology, or IR. By the early 21<sup>st</sup> century, older narratives of national disaster have given way to more 'European' interpretations (e.g., Cramer 2007; Wilson 2009). In addition, the conflict is increasingly placed within its wider contexts that extend from the later 16<sup>th</sup> century to the transformations that occurred around 1700.

In our panel we aim to investigate the roles of 17<sup>th</sup>-century warfare, widely understood, on institutional and state development in broad and comparative perspective that focuses on 'German Europe', i.e., on the Holy Roman Empire *and* the Habsburg monarchy. We are particularly interested in how the various historical, social, economic, literary, and artistic dimensions attempted to navigate the stormy seas of international relations during the crisis-ridden 17<sup>th</sup> century. Given the fact that historical research overwhelmingly and traditionally approaches these factors from the perspective of the central institutions (i.e., courts, bureaucracy, and the military), we would like to emphasize bottom-up views to these same events and developments to assess how, if, this shift in perspective may affect well-established interpretations.

We would like to invite paper proposals that present new research on war and peace from the onset of the 'Long Turkish War' to the end of the War of the Spanish Succession. We are seeking proposals dealing with a wide range of topics, media, and sources that allow our panel to transcend the narrowness of post-1800 national historiographies and linguistic boundaries and to more inclusively assess the current state of research on this period and from this particular perspective.

**Mein Vortrag** zum u.a. Thema fand am **Freitag, 10. März 2018** statt:

**Title:** State Disintegration and Social Disruption in the post-30 Years' War Habsburg monarchy

**Abstract:** My paper focuses on administrative confusion and social disruptions in the Habsburg monarchy in the second half of the 17<sup>th</sup> century. I will demonstrate that these two aspects were the by-product of state formation in early modern composite monarchies. Whereas the advent of the 'fiscal-military state' (Brewer 1989) transformed our understanding of central bureaucracies over the past three decades, these days most studies of early modern state formation apply top-down perspectives.



By contrast, my paper approaches the Habsburg monarchy's re-emergence after 1648 based on two distinctively different premises: First, individual actions and structural developments entail differing consequences for central institutions and the geographically more remote areas; and, second, by analysing these developments from outside the courtly and urban settings, I am arguing that state integration in the centre was accompanied by increasing state *disintegration* and loss of cohesion on the lower administrative levels. As the central government tried to cope with war-induced stress, its actions started to tear apart the administrative and social fabric that held traditional society together. By emphasising the crucial role of local actors, regional interlinkages, and the disintegrating consequences that warfare had on state formation, my book offers a counter-narrative to traditional interpretations in the fields of History, IR, and Historical Sociology.

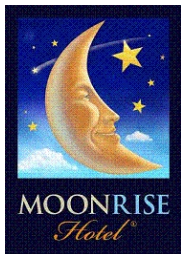
